NOTICE OF LIABILITY: UNCONSTITUTIONAL & UNHEALTHY MANDATES

This Notice of Liability has been SERVED to you personally.

You may be held personally liable for any harm and death caused by the unconstitutional requirement of mandating masks to be worn by any citizen who lives or visits the geographical area for which you have been elected or hired to represent, manage, educate, care for, or otherwise interact in a professional capacity, including but not limited to, educational & recreational facilities, businesses, and places of worship. You may also be held personally liable for the implementation and/or requirement on a framework for the issuance, verification and acceptance of interoperable certificates on vaccination, testing and recovery to facilitate free movement during the COVID-19 “pandemic”, which is designed to coerce widespread acceptance of experimental gene therapy under the guise of vaccination. If you take any action to continue supporting mask requirements, required implementation of COVID testing and/or vaccine requirements facilitating free movement of citizens, and if you take no steps to mitigate your past actions supporting such implementation, you may be held personally liable for resulting harm and death.
