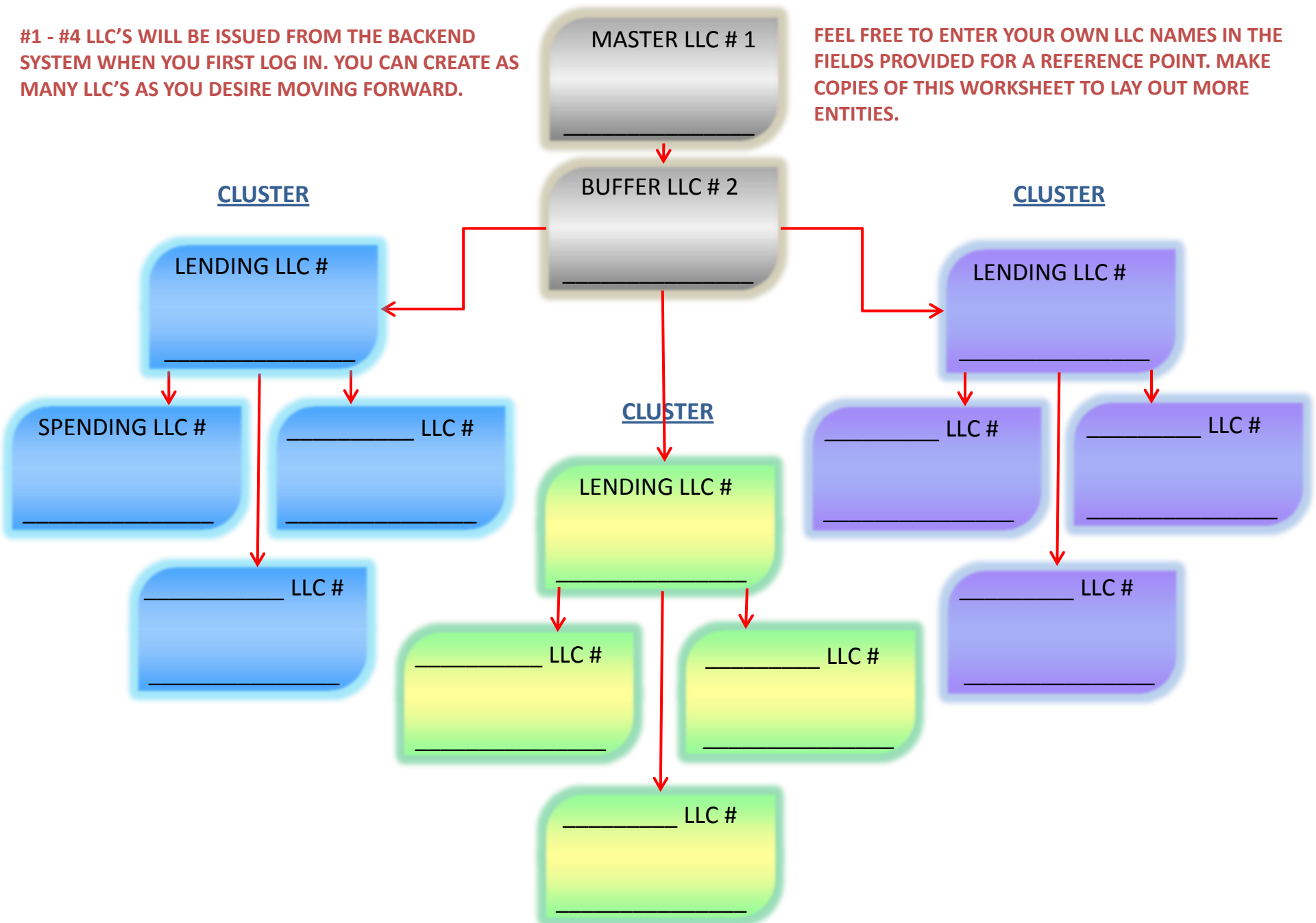


#1 - #4 LLC'S WILL BE ISSUED FROM THE BACKEND SYSTEM WHEN YOU FIRST LOG IN. YOU CAN CREATE AS MANY LLC'S AS YOU DESIRE MOVING FORWARD.

FEEL FREE TO ENTER YOUR OWN LLC NAMES IN THE FIELDS PROVIDED FOR A REFERENCE POINT. MAKE COPIES OF THIS WORKSHEET TO LAY OUT MORE ENTITIES.



NOTE: Never have more than 3 asset LLC's associated with a Lending LLC. Continue to create CLUSTERS with 1 Lending LLC as needed for 3 asset LLC's

MASTER LLC = LLC #1 – NOT TO BE USED FOR ANYTHING BUT HOLDING ACCOUNT & TO MOVE FUNDS TO BUFFER LLC

BUFFER LLC = LLC #2 – ONLY TO BE USED TO MOVE FUNDS FROM MASTER TO LENDING LLC'S.

LENDER LLC = LLC #3 – THIS LLC IS USED TO LOAN OTHER LLC'S FUNDS FOR MAJOR ASSETS SUCH AS HOME, CARS, BOATS, EXPENSIVE JEWELRY ETC. NOTE: LOAN DOCUMENT EXAMPLE WILL BE SUPPLIED FOR YOUR USE.

SPENDING LLC = LLC #4 – THIS CAN BE A LOAN SAY FOR \$1,000,000 TO BE PAID BACK IN 5 YEARS OR SO. THIS ACCOUNT YOU "COULD" USE IN A LOCAL BANK WITH EIN IF DESIRED. YOU MAY FIND THAT WITH HOW FCUSA IS SET UP YOU MAY NEVER NEED AN EIN FOR YOUR LLC'S.

ALL OTHER LLC'S – EACH MAJOR ASSET WILL BE PLACED IN A DIFFERENT LLC OF IT'S OWN. THE LENDER LLC CAN FILE A UCC AGAINST THE PROPERTY WITH THE STATE FOR THE VALUE OR LOAN AMOUNT OF ASSET. THIS WILL HELP PROTECT THE ASSET FROM BEING TAKEN FROM LAWSUITES.

LENDER LLC = LLC'S #7 & #11 – THIS LLC IS USED TO LOAN OTHER LLC'S FUNDS FOR MAJOR ASSETS SUCH AS HOME, CARS, BOATS, EXPENSIVE JEWELRY ETC. NOTE: LOAN DOCUMENT EXAMPLE WILL BE SUPPLIED FOR YOUR USE.
